The 7th International Monika-Sikorska-Wojtacha Piano Competition Wieliczka 2024, Poland

Rules

- 1. The Organizer of the 7th International Monika Sikorska-Wojtacha Piano Competition is the Music School Complex in Wieliczka, Poland.
- 2. The aim of the Competition is to confront the artistic achievements of students of music schools, exchange pedagogical experiences between teachers and popularize piano music of the 20th and 21st century from around the world, and in particular the work of Polish composers.
- 3. The Competition will be held from **June 04 June 06, 2024** at the Music School Complex in Wieliczka, Rynek Górny 6, 32-020 Wieliczka.
- 4. The Competition is open to students of 1st and 2nd degree music schools. It will be divided into five age categories:
 - category I born in 2013 and younger
 - category II born in 2011 and younger
 - category III born in 2009 and younger
 - category IV born in 2007 and younger
 - category IV born in 2005 and younger
- 5. First prize winners of previous editions of the Competition may not take part in the same category.
- 6. Students of the Jury Members are not allowed to participate in the Competition.
- 7. The International Jury will be chaired by Profesor Andrzej Pikul (The Krzysztof Penderecki Academy of Music in Krakow).
- 8. The Jury awards prizes and distinctions and may award special prizes and the Grand Prix.
- 9. The decisions of the Jury are final, indisputable and irrevocable.
- 10. The Competition will end with the Laureates' Concert combined with the ceremony of awarding prizes and diplomas.
- 11. All laureates of the Competition are obliged to participate in the Laureates' Concert.
- 12. For organizational reasons, unclaimed diplomas and awards will not be sent.
- 13. The Organizers of the Competition predict Workshops conducted by Members of the Competition Jury (after its completion). Active participants of the Workshops will be selected during the Competition.
- 14. Applications should be sent **from March 15 to April 30, 2024** electronically using the form provided on the school website: www.smuzwieliczka.edu.pl. The Competition Office will decide about participation in the Competition after accepting the repertoire sent in the application.
- 15. In the participant's application, please specify the duration of the presentation, not exceeding:
 - in category I 12 minutes,
 - in category II 15 minutes,
 - in category III 20 minutes,
 - in category IV 45 minutes.
 - in category V 45 minutes.

- 16. If the time limit is exceeded, the Jury may interrupt the performance.
- 17. The pieces can be performed in any order. The program must be performed by heart with the exception of the 20th and 21st century compositions containing aleatory episodes.
- 18. The Organizer asks to use the original music sheets as well as to make them available for inspection by the Jury.
- 19. The order of the participants' presentations will be determined by the Organizer. Information on the date of the audition and acoustic rehearsals, including the rehearsal on the competition instrument **YAMAHA S6X**, will be placed on the website of the Music School Complex in Wieliczka.
- 20. The Organizer reserves the right to change the schedule of the Competition.
- 21. The entrance fee should be paid enclosing the note "Konkurs Pianistyczny" to the following bank account:

Participants from abroad could pay a fee of 160 PLN on-site, the day of arrival.

- 22. Confirmation of payment (participants from Poland only) should be sent with the application until **April 30, 2024**.
- 23. In the event of cancellation of participation in the Competition, the fee will not be refunded.
- 24. Participants cover the costs of travel, accommodation and meals on their own.
- 25. The Organizer reserves the possibility of free recording and release of material from the auditions and the Laureates' Concert.

- 3. Freely chosen piece composed in 1950 or later, or piece selected from among the piano works of composers such as: C. Debussy, M. Ravel, B. Bartók, W. Lutosławski, S. Prokofiev, D. Shostakovich.

CATEGORY III:

- 1. A polyphonic Baroque piece.
- 2. Freely chosen etude or a virtuoso piece.
- 3. Freely chosen piece composed in 1950 or later, or piece selected from among the piano works of composers such as: C. Debussy, M. Ravel, B. Bartók, W. Lutosławski, S. Prokofiev, D. Shostakovich

CATEGORY IV and V:

- 1. A polyphonic Baroque piece.
- 2. Freely chosen etude or a virtuoso piece.
- 3. Freely chosen Classical or Romantic form.
- 4. Freely chosen piece composed in 1950 or later, or piece selected from among the piano works of composers such as: C. Debussy, M. Ravel, B. Bartók, W. Lutosławski, S. Prokofiev, D. Shostakovich.

Comments to the program:

- 1. Individual elements of the program should be chosen to show the full range of skills of the participant.
- 2. Profesor Andrzej Pikul awards the Special Prize for the best performance of the "Bagatelles" by Krystyna Moszumańska-Nazar.
- 3. Execution of the "Bagatelles" includes at least 2 Bagatelles. The piano sheet music can be ordered through Polskie Wydawnictwo Muzyczne (Polish Music Publishers) on request. Possibility to order by e-mail: sales@pwm.com.pl
- 4. The Jury may award a Special Prize for the best performance of an avant-garde piece.
